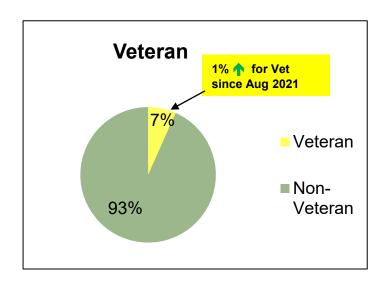


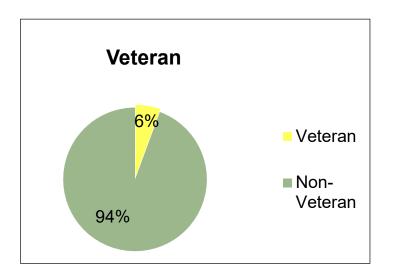


#### MID-YEAR BOARD DEMOGRAPHICS (12/31/21)

Region

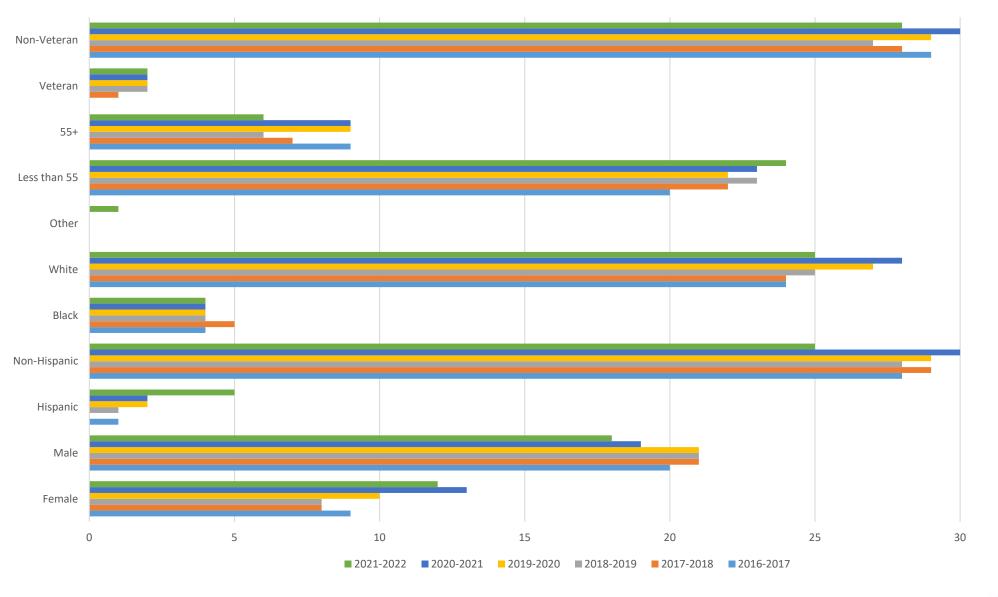






#### **HISTORICAL BOARD DEMOGRAPHICS FY 2016 - PRESENT**

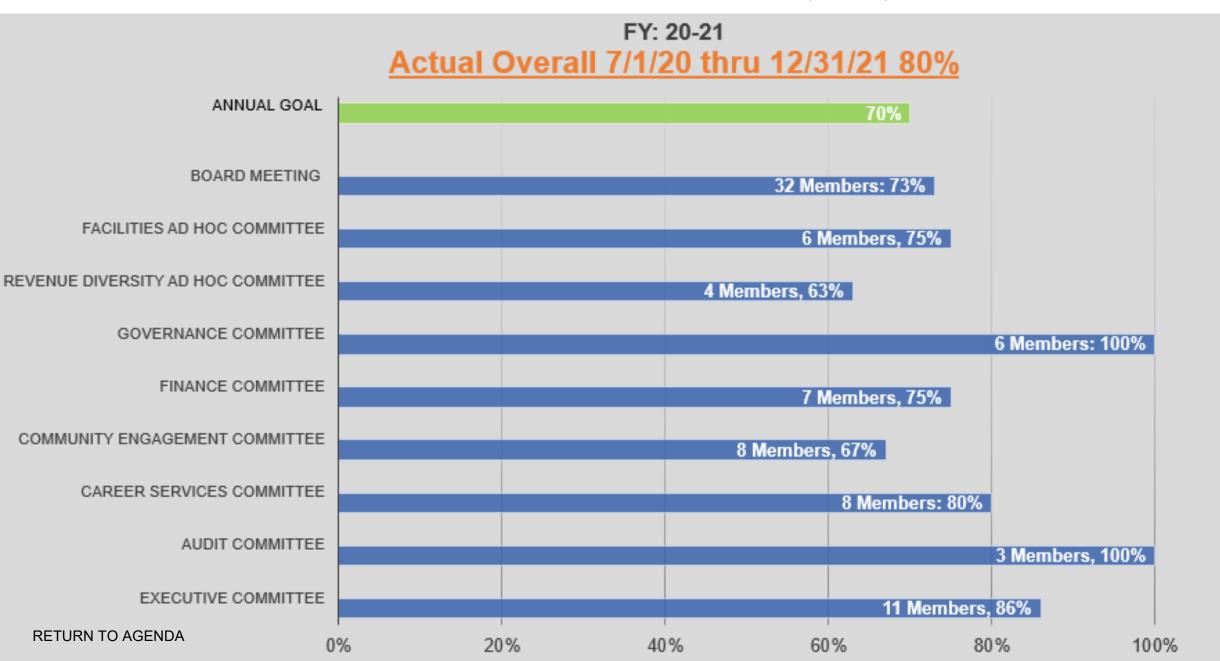

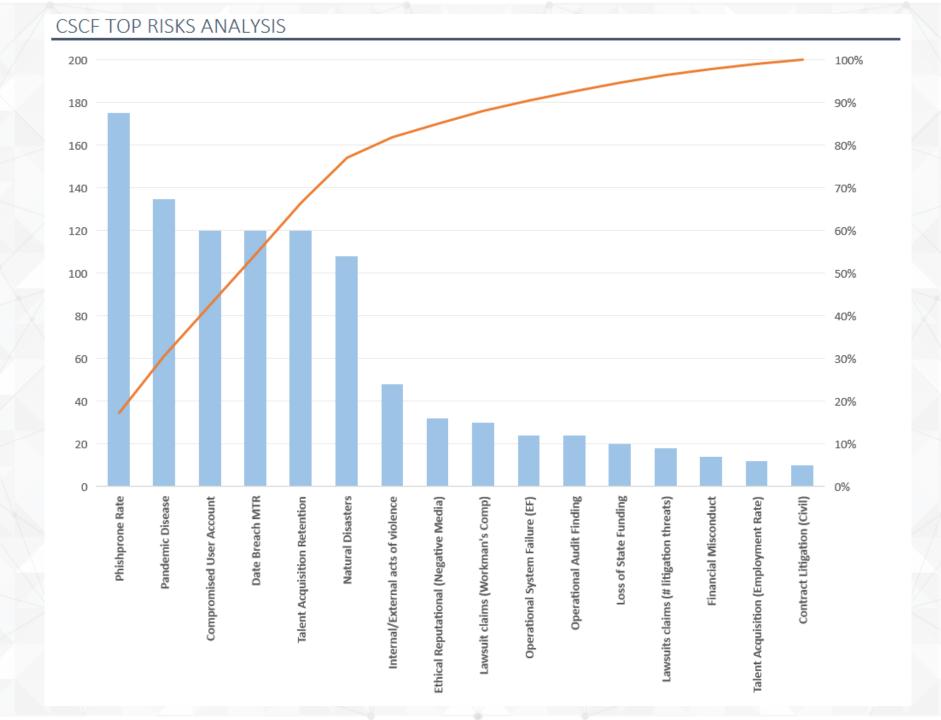

#### 1. Pandemic Disease

- Risk Priority Number = 200
- 2. Phishprone Rate
  - Risk Priority Number = 200
- 3. Compromised User Account
  - Risk Priority Number = 160
- 4. Data Breach
  - Risk Priority Number = 120
- 5. Talent Acquisition & Retention
  - Risk Priority Number = 80



#### **2022 Enterprise Risk Priorities**

- 1. Phishprone Rate (+1)
  - Reduction 200 to 175
- 2. Pandemic Disease (-1)
  - Reduction 200 to 135
- 3. Compromised User Account (+1)
  - Reduction 200 to 120
- 4. Data Breach (+1)
  - Static at 120
- 5. Talent Acquisition & Retention (+1)
  - Increase 80 to 120



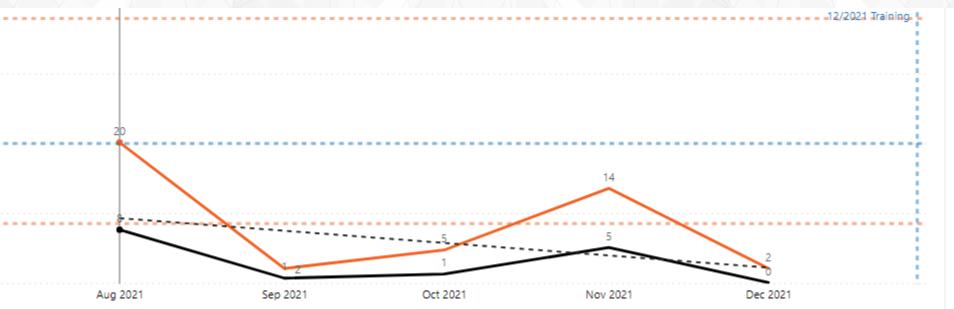
#### **Prioritizing Phishing Awareness**

- Phishing is now the #1 risk to the CSCF organization by Risk Priority Number.
- 91% of cybersecurity attacks start with a malicious email, clicking a link, or entering your info into websites.
- CSCF is entrusted with millions of public data records.



#### **Prioritizing Phishing Awareness**

- Elevate <u>CareerSourcer Technical Competency</u>
  - CareerSourcers completed required Phishing training December 2021.
  - IT phishing campaigns sent out monthly.
  - Increase "IT Talks" and cybersecurity examples with gamification.
