Questions/CSCF Responses:

- 1. Is this a "winner take all" grant or is it broken down by post-secondary institution?
 - CSCF Response Hi @Dr. Jeff, this is not a "winner take all" grant; CSCF looks to contract/partner with multiple organizations.
- 2. Are adult education students allowed to participate or just high school students?
 - CSCF Response Hi @Dr. Jeff, for the summer program, only high school students. :)
- 3. STEM and Healthcare is very broad, can you provide some program examples?

- CSCF Response We want it to be broad, on the Explore side we want it to be as broad as possible, even in Healthcare we would love to see data analytics shared or sustainable facility operators. We want to get the vast majority of career options out there for kids. In Engage, you can get to some very refined areas, there is a particular interest in simulation and virtual reality, as there are so many employers looking for that. There are also a lot of people talking about data, GIS, we would love to see GIS proposals because there are so many sectors that are looking to hire GIS talent.
- 4. Paragraph 2 of Section 3 says institutions w/ physical locations must be onsite for some portion of the program. Does this mean no 100% virtual programs; only hybrid or F2F programs will be accepted? If so, how will this be clarified for students seeking online only due to accommodate family commitments or transportation issues?
 - CSCF Response It will only be face to face/onsite.
- 5. Could public safety be included? Maybe paramedic/EMT for healthcare?
 - CSCF Response We have a separate opportunity in the works, CSCF has a public sector academy coming in the near future. Go ahead and propose to this RFP and we will evaluate if the proposal is a good fit for this RFP or if it will be a better fit for the public sector.
- 6. Will we get a copy of this presentation?
 - CSCF Response Yes, it will be posted to the CSCF Website -
- 7. Can we have a copy of this PowerPoint?
 - CSCF Response Yes, it will be posted to the CSCF Website -
- 8. Will participants be limited to low-income families/students?
 - CSCF Response Majority of funding is for low-income families/students; however we have secured funding from other sources to accommodate those who do not qualify as low-income.
- 9. Will a representative from career source will help establish eligibility for students?
 - CSCF Response Yes
- 10. When will the summer guidance rules be available from career source? My question is about if after the award of funds will there be additional rules offered?
 - CSCF Response In terms of something more restrictive from CSCF, no, we are here to partner with everyone collaboratively. There is no anticipated change to any rules.
- 11. Do you anticipate the same amount of awards (1 or 2 per County) for Engage as well?
 - CSCF Response No, because we think there will be many more Engage partners, as the participant numbers are typically less per program. We have a new fundraising VP, so our goal is to get more programs built. We have amped up to \$700K in funding thus far already.
- 12. Is there a cost range per student?
 - CSCF Response Yes, typically between \$1,200 1800 per student/per class.
- 13. Are Spanish-version programs welcome?
 - CSCF Response Potentially, let us know if you can host a program in Spanish, as there is potential that we would utilize this offering.
- 14. How early do you anticipate being able to give student lists to providers this year?
 - CSCF Response Early, as early as possible. Possibly up to two months' notice.

- 15. Are you open to programs within Engage that are an exploration of careers in one specific industry? For example, if a student loved manufacturing from the previous year's Explore offering, could they do a deep dive in Manufacturing this year in Engage?
 - CSCF Response This year we do not anticipate having this option, but we will have a more intentional connectivity for PY24.
- 16. When will the award be active?
 - CSCF response Early January is the goal to execute the contracts
