**PURPOSE: One class is being cancelled – Was 5 classes, is now 4 classes**

**DESCRIPTION OF CHANGES:**

- **STATEMENT OF WORK – Page 3 – First Bullet – Now Reads: Serve up to eighty (80) participating school enrolled youth, between the ages of 15 and 19.**
- **Services to be provided by CareerSource Central Florida (CSCF) include the following: Page 5 - Provide administrative oversight and case management services to recruit and provide mentorship to up to eighty (80) participants.**

- **ATTACHMENT B – PAYMENT TERMS (page 7) first paragraph now reads:**


**Contractor shall invoice CSCF, in accordance with PAYMENT TERMS outlined within this Attachment. Per this Agreement, total costs for Contractor’s participation in CSCF’s 2023 Youth Engage Program will not exceed \$108,000. Business-related travel expenditures, including mileage, hotel accommodations, food, and beverages are not reimbursable under this Contract, regardless of purpose.**

- **Payments will be split into two increments as follows now reads:**

<b>TOTAL PAYMENTS TO CONTRACTOR</b>	<b>\$108,000</b>


