**CONTRACT BETWEEN  
CareerSource Central Florida (CSCF) AND  
NET Training Institute, Inc. d/b/a International Association of Professional  
Recovery Coaches (ICARE)**

**EFFECTIVE DATE OF CONTRACT:** November 1, 2021 – October 31, 2023

**DESCRIPTION OF CHANGE:** The purpose of **Modification No. 01** to **Contract No. ICARE-CBTS-PY21-22-1**, Vendor Agreement between CSCF and ICARE is to:

- Modify contract period
- Modify Service delivery dates
- Add renewal language
- Modify TERMS language
- Modify Attachment E: General Provisions to add two new federal flow down clauses.

**CHANGES INCLUDED IN THIS MODIFICATION ARE AS FOLLOWS:**

- On page 1:
  - Contract Period changed from November 1, 2021 – October 31, 2023, to November 1, 2021 – June 30, 2022
- On page 2:
  - Language now reads: All services must be delivered between November 1, 2021 and shall end on June 30, 2022.
  - Adding the following renewal language: CSCF reserves the option to negotiate for continued services with ICARE for an additional two program years, depending upon vendor performance and funding availability and at the sole and absolute discretion of CSCF.
- On page 4 TERMS:
  - Language now reads: CSCF has a goal to train 60+ HR professionals between 2022 – 2024. To help CSCF meet this objective, ICARE will deliver two 20-hour blended-learning Addiction Awareness in the Workplace for Human Resources training programs to CSCF in PY22. Each program will be approved for 20 hours of SHRM recertification credit. The program will meet the goals and fulfill the learning objectives defined above. Training classes will be scheduled for March/April and May/June of 2022.
- On ATTACHMENT E, CONTRACTOR PROVISIONS, CERTIFICATIONS AND ASSURANCES:


**XXVIII. E-VERIFY**


