**CONTRACT BETWEEN

And
NEW YORK WIRED FOR EDUCATION**

EFFECTIVE DATE OF CONTRACT: October 16, 2017 – October 15, 2020

DESCRIPTION OF CHANGE: The purpose of Modification No. 03 to Vendor Agreement WIOA-METRIX-1718-016 between CareerSource Central Florida and New York Wired for Education is to:

- Include Option Yr. #2(a), which extends contract period end date of Option Yr. #2, from June 30, 2020 to October 15, 2020.
- Increase contract value accordingly based on pre-negotiated billing rate of 3.5-month extension by \$14,600.

ADDITIONAL CHANGES IMPLEMENTED AS A RESULT OF MODIFICATION NO. 03:


- **Page 1 (Title Page of Base Contract)**
 - Revise performance period to read October 16, 2017 – October 15, 2020.
 - Change the contract expiration date to October 15, 2020.
- **Page 3**
 - Delete the 4th paragraph in its entirety and substitute the following paragraph in lieu thereof:
In return, CSCF shall compensate Contractor for services rendered in an amount not to exceed \$150,000.00. Breakdown of \$150,000.00 includes \$50,000.00 during Base contract period, \$50,000 during Option YR #1, \$35,400 during Option Year #2, and \$14,600 during Option Year #2(a), in accordance with the Payment Terms of this Agreement, unless otherwise modified by mutual consent of both parties.
- **Page 6**
 - **ATTACHMENT B** – Amend the first paragraph entitled, **1. COMPENSATION AND TIME PERIOD**; change the not-to exceed value from \$50,000 to \$150,000.00.
- **Page 7**
 - **ATTACHMENT C** – Revise breakdown of Total NOT-TO-EXCEED Contract Value for Base Contract and Option Periods as follows:

Option Year #1	\$ 50,000.00	October 16, 2018 - October 15, 2019
Option Year #2	\$ 35,400.00	October 16, 2019 - June 30, 2020
Option Year #2(a) - MOD #03	\$ 14,600.00	July 1, 2020 - October 15, 2020
Total Contract Value	\$ 150,000.00
